## GUIDELINES/RULES:

- ❖ All family friendly acts welcome - must be 18 years or older to enter.
- ❖ The maximum number of acts to audition is 50. Each act will be assigned a specific time to audition on Saturday, March 13, 2010. A member of the East County's Got Talent Committee will call you with your audition time.
- ❖ Performances should be no longer than 3-5 minutes (including set up and exit).
- ❖ Judges at the auditions will determine the qualifying acts that go onto the East County's Got Talent main event to be held on Friday, April 23, 2010 at Mt. Hood Community College at 7PM. The judges will rate auditions on overall talent, performance, showmanship/presence and creativity.
- ❖ Bring your own props, costumes, or musical instruments - all that your act requires. Entrants using musical accompaniment should bring music ready and cued on a CD.
- ❖ Qualifying acts will be notified no later than Monday, March 22<sup>nd</sup>.
- ❖ Qualifying acts must be able to arrive at ECGT main event on April 23<sup>rd</sup> by 5PM for rehearsal run though.
- ❖ A separate team of judges will select the prize winners at the ECGT main event on April 23<sup>rd</sup>.
- ❖ Photo ID (Drivers License/State ID or Passport) will be requested at the auditions to confirm age eligibility.
